Sub: Intimation with regard to the decision of the Standing Committee of Bar Council of India granting extension of approval of affiliation to R.D. Singh Vidhi Mahavidyalaya, Prayagraj, Uttar Pradesh for imparting 3-year LL.B. degree course with intake of two (2) sections of 60 students alongwith one (1) additional section i.e. total three (3) sections of 60 students in each section for the academic year 2025-26 subject to compliance of Rules of Legal Education, 2008 and all circulars/directives/guidelines/notifications issued from time to time by the Bar Council of India with respect to maintenance of standards of Legal Education.

CLE to furnish a duly notarised compliance affidavit (Annexure - C/A) with adequate photo/documentary proof in this regard, with all pages of affidavit, annexures, photos, being duly notarised within 6 months from the date of receipt of this letter.

Request for one (1) more additional section was declined in the 3-year LL.B. degree course on account of inadequate infrastructural physical and academic deficiencies as enumerated in Rules of Legal Education 2008 (Schedule III), read along with circulars, guidelines, notification and directives issued time to time by BCI for maintenance of standards of Legal Education.

Sir/Ma'am,

This is to bring to your kind knowledge that the Standing Committee of the Legal Education Committee of the Bar Council of India in its meeting dated 11.10.2025 has considered the inspection report of **R.D. Singh Vidhi Mahavidyalaya, Prayagraj, Uttar Pradesh** submitted by the Inspection Team.

The Centre of Legal Education (CLE) has applied for extension of approval of affiliation for imparting 3-year LL.B. degree course with intake of two (2) sections of 60 students in each section for the academic year 2025-26.

The Centre of Legal Education (CLE) has also applied for two (2) additional sections of 60 students in 3-year LL.B. degree course for the academic year 2025-26.

After consideration, extension of approval of affiliation has been granted to R.D. Singh Vidhi Mahavidyalaya, Prayagraj, Uttar Pradesh for imparting 3-year LL.B. degree course with intake of two (2) sections of 60 students alongwith one (1) additional section i.e. total three (3) sections of 60 students in each section for the academic year 2025-26 subject to such conditions as imposed by the Inspection Team of Bar Council of India which have been approved with additions/modifications, where necessary by the Standing Committee in order to ensure compliance with Rules of Legal Education, 2008 and as per other stipulations/enumerations in the Rules of Legal Education & other guidelines/circulars issued in this regard from time to time by Bar Council of India.

Approval of affiliation was granted for one (1) additional section and request for one (1) more additional section was declined in the 3-year LL.B. degree course on account of inadequate infrastructural physical and academic deficiencies as enumerated in Rules of Legal Education 2008 (Schedule III), read along with circulars, guidelines, notification and directives issued time to time by BCI for maintenance of standards of Legal Education.

Specific conditions imposed by the inspection team and duly modified where required and approved by the Committee which are required to be complied with are as follows, failing which approval of affiliation granted may be withdrawn and future approval may not be considered:-

1. Short-fall of documents: The CLE to submit the documents relating to-

- a) Updated University prescribed Syllabus for 3-year LL.B. course
- b) Registration Certificate of the Samiti (Society), namely, Subhagi Devi Shikshan Sewa Sansthan, Sahson, Prayagraj, its objectives and other terms and conditions.

2. UGC scale of Pay, Salary Slip etc:

- a) UGC scale of pay.

The Principal and all other faculties be paid UGC scale of pay.

- b) Salary slip

The Salary Slip of the Principal and faculties and bank statement mentioning payment of salary to the faculty concerned be submitted to the BCI quarterly.

- c) Authenticated copies of appointment letters of the Principal and all faculties with their PAN and Aadhaar numbers be submitted to the Bar Council of India.

3. Biometric Attendance Systems (BAS):

The CLE to implement the directions of the Bar Council of India notified vide circular no. BCI :D:5186/2024 (LE Circular No.13/2024) dated 24.09.2024. As per said directions, the CLE is required -

- (a) To install Biometric Attendance Systems (BAS) in each Classroom.
- (b) To install CCTV cameras surveillance in classrooms and key areas of the CLE and creates a database, and that
- (c) The recordings from these cameras be preserved for a period of one year to support any necessary verification or investigation related to student attendance and conduct.

4. Library:

- a) The CLE should purchase more authoritative text books and reference books in law by authors of repute worth minimum of Rs. 10 (ten) Lacs in terms

of clause 15 of Schedule III of Rules of Legal Education in addition to existing books and journals.

b) Books, journals periodical etc in the library be properly classified and catalogued as per Dewey Decimal Classification (DDC).

c) There shall be adequate reading space for at least 25% of the enrolled students as per Clause 4 of Schedule-III of Rules of Legal Education, 2008

d) The CLE to appoint a duly qualified and properly trained Librarian.

5. Computer lab.

The CLE should subscribe and continue to update the same for uninterrupted accessibility to legal data bases including online journals in the Computer lab.

6. Class rooms:

a) All classrooms be equipped with appropriate size Dais, a standard Teachers' Table and a decent Chair (not plastic).

b) All classrooms be furnished with standard sitting arrangement and replace the worn-out desk-benches to accommodate 60 students restfully.

7. Moot Court:

(a) Overall ambience and setting of the Moot Court Room be perfected.

8. Legal Aid Centre (LAC):

(a) Signage of the Legal Aid Centre be displayed outside and inside the LAC room specifying the services available in the Centre, ongoing activities etc and the person to be contacted.

(b) Steps should also be taken for adequate publicity of the Legal Aid Centre of the CLE in collaboration with the District Legal Service Authority (DLSA) as per Clause 11, Schedule- III of Rule 11, Legal Education Rules, 2008.

9. Boys' Common Room:

a) Boys' Common Room be adequately furnished with proper sitting arrangement, preferable, comfortable Chairs or Sofa and Centre- Table.

b) Necessary First aid kits, proper indoor game facilities be also provided.

10. Ramp and Lift:

a) Ramp to be constructed and facilitated with 'anti-skid mate' and anti-rust safety railing linking all floors of the building of the CLE.

b) Provision for Lift may also be considered in the building of the CLE.

11. Disaster Management Fire safety:

a) In addition to existing fire extinguishers' provisions, there should be regular fire prevention and fire preparedness exercises, and training.

b) Other measures including Emergency Exit Lighting and provision for fire alarms in the CLE be installed.

FURTHERMORE, every CLE is required to furnish a duly notarised compliance affidavit attached as ANNEXURE C/A with adequate photo/documentary proof of compliance of Rules and Regulations of Legal Education, along with all circulars, directives issued by BCI, with all pages of affidavit, annexures, photos, being duly notarised within 6 months from the date of receipt of this letter.

Authority letter has to bear original signature as on Govt. id like PAN Card/Passport, FULL NAME, DESIGNATION, MOBILE NUMBER AND EMAIL ID of person issuing authority letter as well as of person who is being issued authority letter.

No agents/touts or unauthorised personnel shall be entertained at any cost.




